## UNIT DESCRIPTION

### CHCCS011 – Meet Personal Support needs

Describes the skills and knowledge required to determine and respond to an individual's physical personal support needs and to support activities of daily living.

### CHCCCS015 – Provide Individualised Support

Describes the skills and knowledge required to organise, provide and monitor support services within the limits established by an individualised plan.

### CHCLEG001 – Work Legally and Ethically

Applies to community services and health workers who play a proactive role in identifying and meeting their legal and ethical responsibilities.

### HLTWHS002 – Follow Safe Work Practices for Direct Client Care

Describes the skills and knowledge required for a worker to participate in safe work practices to ensure their own health and safety, and that of others in work environments that involve caring directly for clients. It has a focus on maintaining safety of the worker, the people being supported and other community members.
